## Vaccine Info Sheet # 2: Systemic Pharmaceutical Corruption

**The vaccine industry** has unimaginable wealth and unparalleled influence in media, medicine, and public policy. **No one should be required to ingest or inject a product** from an industry with such tarnished history, corrupt business practices, and **NO liability**.<sup>1</sup>

- **In 2014**, pharmaceutical companies had **\$1 trillion in global sales**,<sup>2</sup> with vaccines accounting for **\$33 billion**.<sup>3</sup> **2016 vaccine sales are estimated to be \$52 billion**.<sup>4</sup>
- The pharmaceutical industry is the **biggest defrauder of the federal government under the False Claims Act**.<sup>5</sup> In the last few years **pharmaceutical companies** have agreed to **pay over \$13 billion** to resolve U.S. Department of Justice allegations of **fraudulent marketing practices**.<sup>6</sup>
- **The CDC** claims to be an independent watchdog over the public health. However, they **took millions of dollars from pharmaceutical companies**, both directly and indirectly, calling their impartiality into question.<sup>7</sup> **Four scathing government studies paint CDC as a cesspool of corruption**, mismanagement, and dysfunction, with alarming **conflicts of interest** suborning its research, regulatory, and policymaking functions.<sup>8</sup>
- An exhaustive study on Pharmaceutical industry corruption authored by 16 Harvard scholars concludes that “certain practices **have corrupted medical research, the production of medical knowledge, the practice of medicine, drug safety, and the FDA’s oversight of pharmaceutical marketing**.”<sup>9</sup>
- In December of 2009, the **World Health Organization** announced on their website: “**Corruption in the pharmaceutical** sector occurs throughout all stages of the medicines chain, from research and development to dispensing and promotion.”<sup>10</sup> **\$27 billion was spent on drug promotion in 2012**, with more than **\$24 billion spent on direct marketing to physicians**.<sup>11</sup>
- The pharmaceutical industry spent over **\$229 million on lobbying activities in 2014, more than any other industry**.<sup>12</sup>

**Preserve Pennsylvanians’ rights to informed consent and vaccine exemptions.
