The protection of children is the cornerstone of civilized humanity. Adults are expected to intervene when children are at risk. *Fever greater than 102.1°F, vomiting that required IV hydration, diarrhea of six or more loose stools in 24 hours, and severe fatigue, severe headache, severe muscle pain, or severe joint pain that prevents daily activity.

Deaths in Ages 0-18 Where COVID-19 Was Indicated on Death Certificate ²

1/290,000 or 0.039%

(You probably cannot see the line that represents these deaths on the pie chart because it is infinitesimal, even on this enlarged version.)

Since only 1,131 vaccinated children 12 to 15 years of age were observed in the 2 month clinical trial, findings were statistically insufficient for proving whether the vaccine is safer than the disease in children 12 to 15 years of age.³

The necessary data for making informed decisions does not exist. Long-term effects may not be realized for years. Even FDA approval will not guarantee safety. Until gold-standard, long-term safety data become widely accessible, every COVID-19 injection is a shot in the dark.

Promoting an experimental product that has no proven benefit to its recipients is unethical. When those recipients are children, it is reprehensible.
