BIG WINS! In October, we received word that SB525 was tabled. This bill would have made it more difficult for individuals to gain information via Right to Know requests in PA. If this bill is introduced in the future, we hope to be able to help with bill language so that citizen groups such as PCIC can maintain our rights. In November, it was announced that the PA Dept. of Human Services sent a notice of termination to Kooth. This is a huge win, as we've worked hard this year to educate about the potential pitfalls of this company and the services they provide.
